

LCC Subcommittee on Minnesota Water Policy Minutes November 12, 2019

Senator Weber called the meeting of the Subcommittee on Minnesota Water Policy to order at 1:00 p.m. in Hearing Room 10 of the State Office Building. A quorum was present.

A motion was made to approve Subcommittee Meeting Minutes from September 17, 2019 and October 17, 2019 was made by Rep. Heintzeman. Motion carried.

The Subcommittee on Minnesota Water Policy Director provided his report and discussed Subcommittee Legislative Priorities. They are as follows:
