



More People Are Moving Into Than Out of America's Disaster-Prone Areas Net inflow/outflow in high-risk and low-risk areas: 2023






## DISASTER OR CATASTROPHE SAVINGS ACCOUNTS

Similar to health savings accounts




## INSURERS OF LAST RESORT IN THE STATES
