




Distinct count of disqualified and disqualification rescinded




Distinct count of <u>persons</u> with at least one disqualified or disqualification rescinded


Count of disqualifying or disqualification rescinded – determination now eligible determination determinations by number of disqualifying crimes and conduct, 2018-2019

Not Applicable. In cases where an individual is not allowed to provide services until either an eligible determination, a set aside, or a variance has been obtained, the risk of harm is not applicable because an individual with a disqualifying determination cannot provide services regardless of their risk of harm unless a set aside or variance is obtained.


High. It is determined that "an individual studied poses an imminent risk of harm". A high risk of harm individual must be immediately removed from service and has 30 days to request a reconsideration. (Minn. Stat. sec. 245C.17 subd. 3)




Low. It is determined that "an individual studied does not pose a risk of harm that requires continuous, direct supervision". A low risk of harm individual is allowed to continue providing services during their reconsideration request period and has 15 days to request a reconsideration. (Minn. Stat. sec. 245C.17 subd. 3)

Medium. It is determined that "an individual studied poses a risk of harm that requires continuous, direct supervision". A medium risk of harm individual is allowed to continue providing services under continuous and direct supervision during their reconsideration request period and has 30 days to request a reconsideration. (Minn. Stat. sec. 245C.17 subd. 3)




