# Minnesota Background Studies 2018-2019 Data Overview Part 1

The information above each section of tables is intended to provide context and understanding on what data is included in each respective section. There are <u>Additional Notes and Data Definitions</u> at the end of this packet with more information on specific terms and data points. The tables start at a high level and then progress into more detail in each section as data is disaggregated further.

# Section 1: Distinct count of determinations and persons by race/ethnicity, gender, and year

Section 1 includes the total counts of distinct determinations and persons with at least one determination by race/ethnicity and gender. All counts throughout this document are distinct counts, meaning they represent the unique number of determinations or persons in each given category. For example, one determination could be associated with three provider applications, but would be counted as one determination. When counting distinct persons, it is important to recognize that a person can have multiple determinations and those determinations can have different results. Therefore, one person could be counted in the category of persons with an eligible determination and the category of persons with a disqualifying determination. Similarly, a person can have one or more determination in multiple years, which means the totals for 2018 and 2019 in Table 2 do not add up to the Grand Total. For example, if one person has a determination completed in 2018 and a determination completed in 2019, they will be counted in both the 2018 and 2019 rows, but will only be counted once in the Grand Total of distinct persons. All counts for a given date range (year in this case) were defined by determinations completed in that year. This date convention is used in all sections.

# Section 2: Distinct count of persons by race/ethnicity, gender, year, and determination type

Section 2 disaggregates <u>Table 2</u> by providing counts of distinct persons with at least one eligible determination (<u>Table 3</u>) and counts of distinct persons with at least one disqualifying determination (<u>Table 4</u>). While the counts in <u>Table 1</u> and <u>Table 2</u> in <u>Section 1</u> included undetermined determinations, these are not included in <u>Table 3</u> and <u>Table 4</u> below because in undetermined determinations, DHS does not make a disqualification decision on the determination (hence the determination is "undetermined"). Since <u>Table 3</u> and <u>Table 4</u> count distinct persons with at least one determination and a person can have one or more determinations in multiple years, the totals for 2018 and 2019 do not add up to the Grand Total. For example, if a person had a determination completed in 2018 and a determination completed in 2018 and a determination completed in 2018 and 2019 rows, however only counted once in the Grand Total of distinct persons.

# Section 3: Distinct count of persons by race/ethnicity, gender, year, determination type, and regulatory agency

<u>Table 5</u>, <u>Table 6</u>, and <u>Table 7</u> in this section represents the same data shown in the tables in <u>Section 1</u> and <u>Section 2</u>, but is broken out by the distinct counts of persons where a provider has submitted background study application. Background applications are connected to the monitoring regulatory agency of the provider (Minnesota Department of Corrections, Minnesota Department of Health, and Minnesota Department of Human Services). Persons are connected to a determination and to a provider application and each provider is associated to a regulatory agency. Since one person may have multiple determinations, and each determination may be associated with multiple applications from different providers who are monitored by different regulatory agencies, the sum of distinct counts of persons associated with each regulatory agencies will not equal the Year Total or the Grand Total in the tables below.

There is a type of determination that is not associated with a provider application. Rapback (Record of Arrest and Prosecutions Back) determinations are generated based on notifications DHS receives about new potentially disqualifying information for a background study subject's (person) prior determination when that person has active affiliation on a provider's roster. Since Rapback determinations are not based on an initial background study provider application they are counted separately in the "Rapback Determination" row below.

Tables 5 through 6 also have an "a" and "b" table below them to show counts for only males and only females.

Section 4: Distinct count of persons by race, year, determination type, regulatory agency, and provider type Table 8, Table 9, and Table 10 follow the same pattern as Table 5, Table 6, and Table 7 in Section 3, but they break out counts further by the provider type grouped by the monitoring regulatory agency. The same notes on why distinct counts within each row do not add up to Year Totals and Grand Totals apply to these tables. Also, determinations can be tied to provider applications that were received after the determination was made. There are some provider types represented in the tables below that did not exist in 2018 or 2019. However, provider applications may have been received after 2018 or 2019 and subsequently tied to existing determinations that were completed in 2018 or 2019 and the distinct persons associated with those studies. Breaking out these data by provider types creates many rows, so Table 8, Table 9, and Table 10 are each split between two pages for better readability.

Tables 8 through 9 also have an "a" and "b" table below them to show counts for only males and only females.

\*\*For this revised overview, gender data was included after the original overview dataset was created. In sections 1-3 gender data was added to the snapshot of data as it existed when the original overview was created, which means all of the counts stayed the same and new breakouts by gender were added. In order to generate the tables in Section 4 with breakouts by gender, it was necessary to re-generate data from the database as there was no static snapshot to which the gender data could be added. Since data in the database is subject to change minute by minute as information is updated and new information is added, data generated at different times only reflects the data as it existed at the time. As a result, some of the totals in the gender tables below are slightly different compared to tables above. For example, in <u>Table 8a</u>, which includes all males with at least one determination completed in 2018 and 2019 the grand total is 92,094 distinct persons. In <u>Table 5a</u>, which also includes all males was generated from the database on a different date than the data generated from the database for <u>Table 5a</u>.

# Additional Notes and Data Definitions

- 1. Background Study **data sources** can include, but are not limited to, state criminal history, federal criminal history, Minnesota Court Information System (MNCIS), Minnesota child and adult maltreatment registries, and the Child Abuse and Neglect Registry (CANR).
- 2. An eligible determination means the background study subject was not determined to have committed a disqualifying crime or conduct in Minn. Stat. sec. 245C.15
- 3. A disqualified determination means the background study subject was determined responsible for a disqualifying crime or conduct in <u>Minn.</u> <u>Stat. sec. 245C.15</u>
- 4. A **background study provider application** is the record created by the provider when submitting a background study request. Background study provider applications can be created by providers at any time. If there is already another background study determination in process for the same person, the new background study application will connect to the in process background study determination (provided the background study requirements are met). In addition, existing background study determinations can transfer to new background study provider application submissions. The connection of background study provider applications to existing background study determinations creates efficiencies for study subjects and providers.
- 5. For an **undetermined determination**, DHS reviews information that was received but does not make an eligibility or disqualification decision on the determination (hence the determination is "undetermined").
- 6. Active roster means the list of individuals specific to an entity who have been determined eligible to provide services for the entity and who the entity has identified as affiliated. See Minn. Stat. sec. 245C.02 subd. 17a (b)
- 7. A **rapback notification** (Record of Arrest and Prosecutions Back) is a notification DHS receives about new potentially disqualifying information for a background study subject with an active provider roster affiliation.
- 8. An **eligible rapback determination** means that the information received through the Rapback process was found to belong to the study subject, but after review was determined to not be a disqualifying crime or conduct.
- 9. The Race/Ethnicity categories captured in the Background Studies system and used in the summarized data above are collected for purposes of a background study fingerprint study. These categories are determined by the FBI CJIS policy and must be used for fingerprint background studies. DHS does not collect other race/ethnicity data that would allow for different or more detailed break outs of racial or ethnic groups.
