### **MEETINGS**

#### MAWSAC-LUAC

Recognizing that land use and water issues are interrelated, the Metropolitan Area Water Supply Commission and Met Council's Land Use Advisory Committee recently held a joint meeting to discuss how they could better integrate the work of each group. Land use planning and water planning are separate efforts that may not be well integrated in every community. Fundamentally, the group is interested in how they can make water a focal point of land use planning and how it can be considered earlier in the development process. Conversations ranged from identifying obstacles and opportunities for collaboration, to interest areas that overlap between the two groups, to how they can leverage resources, to specific outcomes that could emerge as joint initiatives. Once the input is digested, they will formulate a plan for moving forward together. Suggested outcome categories with potential LWC links included: balancing growth with water supply limitations, developing a unified direction on water reuse, retention, and conservation (particularly related to lawn irrigation); improving coordination of legislative initiatives, and increasing coordination across jurisdictions because water boundaries don't match jurisdictional boundaries.

#### **CWC BOC**

The Budget and Outcomes Committee of the Clean Water Council has begun the task of developing recommendations for the full CWC on whether to eliminate, sustain, increase or decrease funding for each of the major program areas for three horizons: the next biennium, 5 years and 10 years. At this point in the process, the agencies are explaining the need for the programs they administer that are funded in whole or part by Clean Water Funds, while also sharing their vision for funding levels across the 3 time horizons. Specific funding amounts are not being discussed at this time. The issue that generated the most debate is how to shift some funding from the planning, monitoring and research areas so there is more money available for implementation of practices that improve water quality and quantity.

#### DWG

In addition to receiving updates on several ongoing issues, the Drainage Work Group tackled these issues at this month's meeting:

- The extraordinary length of time DNR is taking to finish their "permission vs permit" guidance for public waters and drainage.
- A review of the work of a 17 member project advisory committee to identify impediments in drainage law related to compensation for ditch buffer strips and alternative buffer practices. At their first meeting, they identified 15 impediments and prioritized them. They will meet again in a week to suggest options for how to solve impediments and develop consensus recommendations, starting with the top priorities. Their final report and recommendations are due to Legislature by 2/1/18.
- A consensus DWG response to the Clean Water Council's Policy Committee request to provide input on a possible storage and drainage policy was finalized and will be submitted to the CWC. In short, the DWG feels the development of a new policy statement may not be necessary, as it relates to drainage, because the 2016 CWC policy statement is already consistent with existing 1W1P statutes, guidance and plans to date.
- Discussing comments from Smith Partners on proposed changes to drainage law to allow for a runoff and sediment delivery charge option for drainage repair cost apportionment. The new comments were substantive and generated a lot of discussion and significant revisions to the proposed changes. The group was not able to reach consensus today and will resume the discussion at their December meeting.
