

MEETINGS

LCCMR

The Legislative Citizens Commission on Minnesota Resources had two meetings this week. The first was of a subcommittee that is looking at what the role of LCCMR should be in helping to address the state's wastewater issues. They assembled a <u>packet</u> of the materials they have reviewed, including <u>language</u> proposed by Sen Westrom, both of which were advanced to the full LCCMR.

After reviewing and approving 2 work plan amendments and the LCCMR's proposed 2018 bill language, the Commission began discussing their Emerging Issues Account. Because those decisions would likely be entwined with wastewater actions, the agenda was amended to bring the subcommittee's wastewater report forward. Discussion ensued for over an hour, with many concerns expressed, including: the appropriateness of using the trust fund for grants, whether the intent of the enabling legislation was to fund infrastructure projects, what other types of wastewater projects might be a better fit for trust funds, and whether members had enough time to make an informed decision. Several members proposed alternative funding formulas that would help insure trust fund money would only be available for capital projects after a certain level of bonding was made available. Ultimately, they decided to amend the proposal to provide LCCMR funding up to \$10M when there is \$10M in bonding/year for wastewater infrastructure funding program, until June 30, 2021 for the grants. Discussion then turned to the new Request for Proposals, which must be consistent with 12/2013 Strategic Plan (which was reviewed last year). The RFP is essentially the same as the 2018 RFP, with the exception of changed due dates, schedules, member lists and new provisions to support small grant applications. The 2018 LCCMR schedule was approved. The 2018 package bill, with the new Westrom amendment and Emerging Issues appropriation, was approved.

CWC

The Budget and Outcomes Committee (BOC) of the Clean Water Council met this month to continue their process of evaluating the ten-year funding directions for agency programs. Staff from MPCA, DNR and MDH gave brief overviews of their programs that have been supported with Clean Water Funds, as well as projections for their future needs. The BOC concluded their work by deciding whether funding for each program area should remain steady, increase, decrease, or be eliminated across three time horizons: FY20-21, FY23 (5 yr), and FY28 (10 yr). Those recommendations will be presented to the full CWC at their December 18th meeting.




Figure 6. Distribution of 2015 Lake Grades
