### ALPR usage among MN Law Enforcement


Minnesota LE agencies with at least one ALPR device:

### Bloomington's ALPR Program Background

- Program was first proposed in 2012
- Spring of 2013 project began with \$334,105 grant funds
- Project funded by Federal and State Grants



### Mobile ALPR

- Operating 5 mobile ALPR systems on marked squads
- Each squad has 4 cameras
- Mobiles run on Sprint Air Cards
- Funding in 2018-19 Auto Theft Prevention Grant for 1 additional mobile unit at \$18,700

  - 14 MOA ALPR
  - 7 Mobile ALPR

#### Investigative Uses

- Expands investigative capabilities of agencies
- Identifies possible suspects
- Rules out innocent people
- Provides evidence to bolster prosecutions
- Locate shooting / Homicide suspects
- VOTF
- Recover Vehicles



#### **Request For Read Data**

- 2015 = 51 Requests
- 2016 = 111 Requests
- So far in 2017 = 81 Requests



### State Statute 13.824 Automatic License Plate Readers (Effective 08-01-2015)

- 60 day retention period
- Information sharing
- Log of Use
- BIENNIAL AUDIT
- Authorization To Access Data
- Notification to BCA



### **Biennial Audit**

- Independent
- Actual costs between \$5,000-\$7,000
- Involves IS, Detectives, Dispatch, Clerical, Radio Tech
