The Legislative Commission on Minnesota Sports Facilities submits this report as required by Minnesota Statutes, section 3.8842, subdivision 9.

Background

The Legislative Commission on Minnesota Sports Facilities (the "Commission") was established by and under the authority of the Legislative Coordinating Commission to oversee the Minnesota Sports Facilities Authority's operating and capital budget (Minnesota Statutes, 3.8842).

According to the Minnesota Statutes 3.8842; there are three purposes for the Commission. They are:

- 1. providing financial oversight of the authority as described in subdivision 8;
- 2. adoption of a statewide authority structure for the operation and management of sports facilities and entertainment venues under the jurisdiction of the authority. The authority membership shall represent the interests of both the metropolitan area and greater Minnesota; and
- 3. creating a comprehensive management plan that alleviates booking and scheduling concerns regarding the sports facilities and entertainment venues under the jurisdiction of the authority.

Members

The Commission consists of three senators appointed by the senate majority leader, three senators appointed by the senate minority leader, three state representatives appointed by the speaker of the house, and three state representatives appointed by the house minority leader.

At its April 2, 2013 meeting, a co-chair structure was adopted by the Commission. At that same meeting, Senator Champion and Senator Rosen were elected to serve as the Commission co-chairs. At its October 3, 2013 meeting, the Commission elected Representative Brynaert to serve as the Commission vice chair.

Meetings

The Commission convened on April 2, 2013 and has met a total of five times as of January 15, 2014. Meetings were held on April 2, 2013; October 3, 2013; October 24, 2013; November 7, 2013; and December 5, 2013. At the October 3, 2013 meeting, it was decided the Commission would meet on the first Thursday of each month. The January 2nd meeting was rescheduled for January 23rd due to the original meeting's proximity to the holiday season.

Each Commission meeting included an update from the chair of the Minnesota Sports Facilities Authority, Michele Kelm-Helgen.
