RE: Respect in the Workplace/Harassment and Discrimination

We are committed to providing employees a work environment free from unlawful discrimination and harassment. If you believe you have experienced or witnessed such behavior, sexual, discriminatory, or otherwise, you may discuss your concern with the offending person explaining how the behavior is disruptive to a respectful workplace and that the behavior should not continue. The LCC policy Against Discrimination and Harassment also provides the ability for you to explain your concern in person or in writing to the offender; however, you are not required to do so if this would make you uncomfortable.

If you do not feel comfortable voicing your concern directly, if you have communicated your concern to the offender and the offensive behavior has not stopped, or if you believe voicing concern has resulted in retaliation towards you, report your complaint of harassment or of retaliation to any of the following people:
