# CHILDREN IN NEED OF PROTECTION OR SERVICES (CHIPS) DATASET

Records of all placements from cases involving Children in Need of Protection or Services (CHIPS) ordered between January 2019 and June 2023 was obtained from the Court Research Office of Minnesota's State Court Administrator's Office. This included 53,480 juvenile placements broken down to the following placement types/facility categories:

This working group is mainly focused on the subset of placements highlighted above, those ordered to correctional facilities and residential treatment centers (RTC) which comprise 3.95% of all CHIPS placements in the dataset. Here is the breakdown of only these two categories:

Around a third of placements in this subset go to correctional facilities while the rest are placed in residential treatment centers.

There's an even split of placements when broken down by gender and they are twice as likely to end up at an RTC than a correctional facility.

Placement patterns remain consistent when broken down by age at filing (majority are placed at RTCs). 54% of placements were for individuals between the ages of 14 and 17. Nearly a quarter of placements were for individuals 12 years or younger.

#### CHIPS PLACEMENTS TO FACILITY CATEGORIES BY JUDICIAL DISTRICT

Broken down by judicial district, we find districts 1, 2, 4, and 7 get more placements to their correctional facilities than RTCs. Unfortunately, nearly half of the dataset did not have their judicial district identified so caution should be taken when concluding anything from this specific analysis.

In contrast, individuals tend to have their cases result in an RTC placement across the board except for district 9 where there's nearly equal opportunity with correctional facilities inching ahead.

Here is a matric of placements between case judicial district and their resulting facility district:


All districts except for districts 1,2, and 8 had majority of their placements within the same district. These three districts, place within the same district secondarily. Again, this only accounts for 54% of the dataset since 46% did not have facility district location information. Taken in totality, there is still more placements done outside of judicial districts than within:

This is even more stark when looking at placements within the same county which only accounts for just nearly a fifth of all placements per county (170 within versus 977 outside of county).

### CHIPS PLACEMENTS TO FACILITY CATEGORIES BY JUDICIAL DISTRICT (continued)

Here is a spatial map of all CHIPS records by county and their resulting placements either within the same county (light green is 0%, dark green is 100%) or outside their judicial district (light red is 0%, dark red is 100%):



The dataset is dominated by records from Stearns county (104) and St. Louis county (65). Anoka county leads in keeping 78.26% of all their placements within county borders. Several counties have 100% of their placements outside their judicial districts such as the 20 from Goodhue county and 11 from Todd county.
